Objective

The objective of this EOI is to attract organizations which are technologically advanced and capable of "Children's Play Equipments" in Dantewada District.

EOI Opening and Evaluation

All the EOIs submitted on or before the due date, i.e., 7 days from publication will be opened on 7 days from publication at 17.00 hours. Bid will be opened in the presence of those bidders, who chose to be present. District Education Officer, Dantewada reserves the right to accept or reject any offer without assigning any reason whatsoever. Applications received until 7 days from publication will be accepted and considered by committee.

Bid Evaluation

Bidders May submit Specifications of Products Offered for supply of equipment with technical. Specifications and financial specifications. The committee may choose any or all of the products Offered by the Bidder on the basic of estimated Requirements, without assigning any reason Whatever for such selection/rejection.

The Bid evaluation committee will evaluate the proposals on the basis of their responsiveness to the selection criteria followed and discussion. With those representaves who choose to be present. Proposal of equipment financial proposals of only the technically qualified bidders will be taken up for further evaluation by the committee.

Technical specifications required

- PILLARS/POSTS :- All Structure made up of galvanized pipe maximum \varnothing 100 mm to minimum \varnothing 25 mm NB, B class conforming to IS 1239:2004 P.U coated with the layer thickness of 60 micron. All tubing used to manufacture components are electrical resistance welded, hot rolled, and high strength steel tubing.it is used in the various parts likeladder, climber,handrill etc. also with API 5 licence/monogram.
- PLASTIC COMPONENTS :- All plastic structure in multiplay are made from 'VIRGIN LLDPE' granules which is roto moulded to create structures like roof,pannels,slides etc. that are most unique in

design, style and colours. LLDPE has higher tensile strength, flexible and elongates under stress. It has better environmental stress cracking resistance, non-toxic plastic, available at various colour shades (blue, green, yellow, red, ivory, violet, orange) density - 0.94 g/cm³. We do not use any fibre glass. In multilayer - only the world's best plastic which is UV stabilized.

- ROOFS/CANOPY PANELS :- All roofs canopy are made from 100% virgin LLDPE.
- PANELS :- All panels are made from 100% virgin LLDPE.
- HANDRAILS :- The handrail manufactured of 25mm & 32mm O.D. galvanized tube B class conforming to IS 1239:2004 P.U coated with the layer thickness of 60 micron.. All tubing used to manufacture components shall be an electrical resistance welded, hot rolled, high strength steel tubing with API 5 licence/monogram.
- DECKS & STAIRS :- Multiplay rectangular & square decks & stairs are fabricated from 2mm (IS 1239/2004) thick punched steel with a powder coated finish. The deck is a one-piece assembly with applied polyester powder. We offer special punching on platform. It avoids uneven sleepers of childrens/reduces the risk of slip.
- LADDERS :- The ladder assembly fabricated from 2mm (IS 1239/2004) thick punched steel with a powder coated finish. The deck is a one-piece assembly with applied polyester powder. Be fabricated of 32 mm O.D. galvanized pipe with a powder coated finish.
- COLOUR PROCESS :- All components are pu paint over two coat of epoxy primer are free of edges and excess weld splatter and cleaned epoxy primer to prevent flash rusting before coating. The coating have a super tough finish with maximum exterior durability and will have superior adhesion characteristics
- POWDER COATING :- Shall be an electro statically applied with our custom formula of TGIC polyester powder. All components will be free of sharp edges and excess weld splatter and shall be cleaned in a six stage bath system with an iron phosphate wash, as a rust inhibitor and a sealer to prevent flash rusting before coating. The coating shall have a super tough finish with maximum exterior durability and will have superior adhesion characteristics. Typical characteristics are 3.0 mil thicknesses. The process methodology used : Hot rolled steel---- cleaned the edges and weld spatter----- iron phosphate wash----- print rust inhibitor----- drying----- powder coated.
- BEARINGS :- 3 bearings of ISI standards for smooth rolling action. (skf, rbc) these bearings are designed and arranged dynamically to absorb the vertical thrust due to rotational moment and applied weight.
- ROPES :- Net structure made up of high strength static rope of 16 mm thickness.
- PANELS :- All panels are made from 100% virgin H.D.P.E. sheet.
- RUBBER COATED CHAIN NET :- Rubber coated G.I chain of 8 mm thick for smooth gripping purpose and long durability.
- WELDING PROCESS :- We use process according to maintain its material properties and good surface finish. according to the thickness of material.
1. MIG welding process - 5 TO 3 MM THICKNESS
 2. ARC welding process - 1.5 TO 5 MM THICKNESS
