INTRODUCTION

1. The proposals are invited for said work from registered Firms/Contractors/Company.
2. The project envisages the preparation & planning of site with supplying & fixing of containers. Project site is situated within District Dantewada Chhattisgarh. The participant may add, modify or suggest any aspect for preparation of a good and viable plan keeping in view the feasibility of the project.
3. The tender forms could be obtained on any working day by depositing Rs. 750/- at Office of Collector, Jila Nirman Samitti, Dist. Dakshin Bastar, Dantewada (C.G.)
4. The sealed proposals should be submitted so as to reach the Office of the Collector (jila nirman samitti), Dakshin Bastar Dantewada (C.G.) on or before 3.00 PM. of 07.03.2018 through Speed-Post/Registered Post only along with an Earnest Money of Rs.22000/- (Rupees Twenty two thousand) in the form of FDR in favour of the Collector, Jila Nirman Samiti, , Dist. Dakshin Bastar, Dantewada (C.G.)
5. The proposal shall be submitted in a sealed envelope containing three separate sealed envelopes marked as “A” “B” & “C” as detailed below :-
 - (i) **Envelope “A”** :- EMD & EOI document along with Qualifications and experiences and other required documents.
 - (ii) **Envelope “B”** :- drawings, details and other technical information.
 - (iii) **Envelope “C”** :- Price bid. (BOQ)

6. Envelope “A” shall be opened first and examined. Envelope “B” of only those participants shall be opened who have submitted all details required in it.
7. The bid shall be signed by the persons on behalf of the organization having necessary authorization/ power of attorney to do so. Each page of application shall be signed (copy of power of Attorney / Memorandum of association shall be furnished along with the application and Original should be produced subsequently for verification and return.
8. Bidder should refer attached schedule of items ANNEXURE “E” to prepare price bid.

SCOPE OF WORK

1. To transport install and fix the containers at site.
2. To execute all relevant civil works such as pedestals, platforms, drainages, tanks, water supply and sanitary connection etc., if required.
3. The work includes all structural glass, frames, aluminum or GI members, fixtures flooring and ceiling material and all type of electrical connections with necessary appliances etc.
4. Any of the civil work if required should be done according to IS Specifications.
5. Bidder should quote rate for both fully furnished 20 feet as well as 40 feet long container.

TIME SCHEDULE FOR THE SCOPE OF WORK

The time for completion of work is 30 days from the date of issuing work order.

Provision of penalty for delay in work shall be as per tender document. This penalty will be recovered from the contractor's security deposits against this work.

QUALIFICATION CRITERIA

1. The bidder should have duly allotted PAN, TIN, GST PWD & other registration numbers.
2. The bidder should submit INCOME TAX, PAN & TIN NO. GST No., Work experience certificate /documents along with the proposal documents.
3. If the contractor is found ineligible after opening of tenders, his tender shall become invalid and cost of tender document and processing fee shall not be refunded.

FEES PAYABLE

1. Fee payment to the firm will be made stage wise as per progress of work.
2. The rate quoted by the contractor shall be deemed to be inclusive of all Taxes, Labour wages and material cost etc. and should be complete in all respect. Tax deductions at source shall be made as per laws prevalent in the State as applicable for the work.

OTHER TERMS & CONDITIONS

1. No extra payment shall be paid for extra lead and lifts or extra scaffoldings if required.
2. Personal safety equipments for workers shall be provided by bidders.
3. No deviation shall be allowed without any prior information and approval.
4. The Engineer-in-Charge shall have power to make any alterations in, omissions from, additions to or substitutions for, the original specifications, drawings, designs and instructions that may appear to him to be necessary during the progress of the work
5. No claim on account of any escalation on whatsoever ground shall be entertained at any stage of works. All rates as per Bill of Quantities (BOQ) quoted by contractor shall be firm and fixed for entire contract period as well as extended period for completion of the works. No escalation shall be applicable on this contract.
6. The Engineer-in-Charge shall have the liberty to postpone or not to execute any work and the Bidder shall not be entitled to any compensation for non-execution of the work or its part.
7. The materials/products used on the works shall be of approved make/ brands and Quality having necessary ISO and other similar certifications.
8. All terms and conditions given in appendix 2.10 are also applicable. Annexure – J should be duly filled with EOI documents.
9. The agreement shall be governed by the Indian laws in force time to time.
10. Any disputes or differences in connection with the agreement shall be , to the extent possible settled amicably between the parties, if it cannot be reached then, all disputed issues shall be settled by arbitration.
